### 1. Goal of the interview

- **3. Transition question** (general question to move to the topic) e.g., in general, what are your experiences in IQA process of DSMA?

## 4. Core Part

## 4.1 Awareness toward Institutional QA framework

Questions should be "Inductive"- open-ended (not leading questions)

- 1. Have you ever heard about Institutional QA framework in DSMA?
- 2. Could you explore your opinion on Instructional QA framework in DSMA? (for example – is concerned with curriculum components such as teaching learning process/ resources/ assessment/ students/ staff etc.)
- 3. Can you elaborate more how Institutional QA framework is related to implementation of curriculum process or curriculum components?
- 4. Do you think DSMA needs to strengthen the Institutional QA framework? If yes, why it is essential? (to meet accreditation/ to build up quality process/ to be internationally recognized etc.?)
- 5. Who should be inclusive in the Institutional QA framework? Why?

### 4.2 Perception toward Internal Quality Assurance in teaching and learning process

- 1. Can you give your opinion on development of quality assurance system in DSMA?
  - Is there any limitation/ weakness or strength?
  - Can you give incidences to support your opinion?
- 2. What is about your concern on internal evaluation process of QA unit to each department of DSMA?
  - Is it useful or not for improving their departmental works? (is there any reason to support your opinion?)
  - Can you tell me how the departments take action on the feedback provided by QA unit?

- 3. What is about your opinions on learning resources that are regularly offered/ monitored/ evaluated in current IQA process?
  - Can you clarify more your opinion?
  - Can you give evidence to support your opinion?
- 4. How can you suggest to improve IQA process in DSMA?
  - How should be collaborate each other's among stakeholders. e.g., staff, QA office and academic office?
  - Can you elaborate more based on your own feeling?
  - Can you give incidences to support your opinion?

### 4.3 Attitudes towards IQA

- 1. Is there any impact on daily work of faculty members and academic staff by current IQA process (e.g., positively or negatively)
  - Can you give incidences to support your opinion?
- 2. How do you feel about the current quality assurance and accreditation mechanism in DSMA?
  - Is it effective?
  - Why do you say that based on your own feeling?
- 3. How do you perceive in quality culture development in DSMA?
  - Can you tell me how will you take action in enhancement of quality culture?

### 4.4 Practice towards IQA

- 1. Do you involve in the process of IQA at your department or institution?
  - If yes, what about your role in IQA process? (e.g., compulsory/ ordered/ your interest/...)
  - How do you implement in this process? (e.g., responsible person for specific area for your department or institution)
- 2. Do you encourage your colleagues to IQA process implementation?
  - If yes, how do you encourage? (e.g., sharing knowledge/ duty share/ regulation of head of department)
